Sir/Madam,

Jawahar Navodaya Vidyalayas are fully residential institutions where safety and security and well being of the children in the Vidyalaya campus is one of our immediate concern. The Samiti has time and again given necessary guidelines for regular monitoring of safety and security measures in the Vidyalayas. In the recent past, however, there have been some incidents resulting in loss of precious lives of children due to snake bite etc. Examination of these cases have revealed negligence on the part of Vidyalaya administration in taking appropriate safety measures.

1) Since most of the Vidyalayas are located in rural areas and are having vast campus, there are chances of growth of bushes, wild grass and other vegetation in the Vidyalaya campus which will provide habitation for snakes and other poisonous animals. To avoid accidents and insects related disease, it should be ensured that weeds, bushes and long grass in the campus are cleaned every fortnight in the whole campus.

2) Care must be taken to ensure that children are able to move safely within the Vidyalaya campus during night for which focus/flash lights must be installed near students' dormitories and on the internal roads.

This aspect should be closely monitored by Assistant Commissioners, Incharge of Cluster during their visit and immediate action should be taken wherever any deficiencies are observed. Principals of all the JNVs are directed to follow these instructions strictly and any lapse in this regard would be viewed seriously.

It is reiterated that personal responsibility shall be assigned in cases of snake bites where above instructions are not found to have been taken.
