

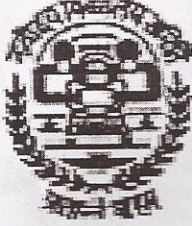

OFFICE MEMORANDUM

Sub : Enhancement of various allowances by 50% from 01.01.2014 due to increase in Dearness Allowance to 100% - reg.

I am to refer to this Office memorandum no. 20-1/2011-NVS(Estt.II)/196 dated 23.02.2012 and Department of Expenditure, Ministry of Finance letter no. 9/11/2014-II(B) dated 22nd May 2014, and to say that automatic enhancement of various allowances by 25% every time Dearness Allowance in the revised pay scale goes up by 50% are implicit in the respective orders issued by Department of Expenditure, Ministry of Finance on implementation of the recommendations of the Sixth Central Pay Commission, and that no separate orders are required to be issued for enhancing these allowances.

The cases of Travelling allowances settled earlier need not be opened.
