2. The afore-mentioned transfer is subject the following conditions: -
- The staff concerned has to serve the mandatory period of two or three years, as the case may be, in the hard and difficult stations and shall not be eligible to seek transfer before completion of the mandatory period.
  - On refusal of transfer, the employee concerned shall be debarred from applying the request transfer for the next three years.
  - No request for change of place shall be entertained.
  - In case a person has been transferred against new creation of post, his / her transfer shall not materialize till the said post is actually sanctioned by the NVS (Hqrs.).
  - The seniority of the employees, other than Post Graduate Teachers (PGTs), shall be maintained in their parent region.
  - No one should be posted to his / her home district in any case.
  - Transfer Benefits is payable as per the Samiti's Rules.
3. The Regional Office concerned should ensure that the staff concerned is relieved from the present place of posting enabling him / her to join at new place of posting latest by 30<sup>th</sup> September 2013 positively.
